- Managed by University Cheikh Anta DIOP de Dakar (UCAD)
- About 2 500 domains names registered
- Working with 10 registrars





Towards a collaborative management of the DNS


To be in harmony with the text and the ECOWAS policy for

 - Nic Senegal




Evolution of domain names

Evolution annuelle au 31/08/2010 (nom de domaine de premier niveau .sn)




Annuel registration

- Several evolutions
- Equal treatment taking into account the laws and regulations in force in senegal
- Acceptance of the named policy
- Principle of responsibility:



How to be Registrars

- Be incorporated in Senegal or recognized by ICANN
- Have at least two DNS servers
- Having a portfolio of 50 domain names per year
- Provide an administrative contact and technical contact to NICSN of any applicant for a domain name.
(physical address, electronic address, phone number, etc)
- List of registrars maintained and published on NIC






The way forward

- Deploy DNSSEC test bed at the end of 2011
- Test DNS with IPV6 OK with recovery project at UCAD
- Setting a WHOIS server.
 - Publishing administrative informations in domain names (whois.nic.sn)
- Software Development for the administrative and the technical management of the DNS: GENODOM
- IXP, Root-server, IPV6, Anycast





CONCLUSION

- With the new organizational structure for management of the .SN, open to all Internet community (régulator, universities, operators, users, registrars, ...)
- Stable business model
